# Specialised Security Training for Air Crews, Aircraft Security Search Personnel and Aircraft Guarding Personnel F1, Recurrent



### 1. Initial Situation

Person has a valid D1, D2, D3 certificate, which validity is about to expire.

### 2. Course Objective

The aim of the Specialised Security Training for Air Crews, Aircraft Security Search Personnel and Aircraft Guarding Personnel is to refresh awareness of aviation security among employees and to fulfil the requirements of the National Security Training Programme in civil aviation, issued Czech CAA

### 3. Entry Requirements

- Valid D1
- Valid Security Background Check certificate issued by Czech CAA.



### 4. Course Description and Duration

This course is focused on specialized security awareness. The classroom instruction is done by fully qualified Security Awareness instructor and is followed by an examination. Successful candidates receive a certificate upon completion. The certificate is valid for 24 months.

Topics covered depends on the type of recurrent (D1, D2 or D3) and can be as follows: Previous civil aviation unlawful acts, terrorist attacks and current threats analysis, Goals and organisation of civil aviation protection, incl. duties and responsibilities of Security check employees, Reporting procedures, Relevant legal requirements, Manners of appropriate reaction to security related events, Security screening point configuration and procedures, Access control and relevant procedures, Airport badges, Prohibited items and their detection, Prohibited items handling (e.g. reaction to discovery), Reconciliation methodology and requirements, Protection of Air Transporter's Check-in supplies, Work-related aircraft configuration knowledge, In-flight safety precautions, Weapons transport procedures, Air marshals-related procedures, Security-related event reaction procedures, Aircraft security search legal requirements, Prohibited items and their detection, Prohibited items handling (e.g. reaction to discovery), Possibilities of prohibited items concealment, Work-related aircraft configuration knowledge, Performing of aircraft security search at the level appropriate for discovery of concealed prohibited items, Aircraft guarding and access control, Aircraft sealing procedures, Airport badges systems, Detention procedures, detention & reporting-related circumstances, Security-related event reaction procedures.

#### 4.1 Theoretical Training

##### ➤ Classroom instruction

- For D1/F1-D1 certificate holders: 3 hours of classroom work with a qualified Aviation Security instructor for each requested category +1 hr of final written test
- For D2/F1-D2 or D3/F1-D3 certificate holders: 2 hours of classroom training

##### ➤ Examination

- Performed by an instructor at the end of the training
- Form of written test
